




Contributing to Sustainability

At HubStar Group our approach follows the recommendations of DEFRA in accordance with the GHG Protocol, in line with ISO 14064-1 and we are aligned with the recommendations covering the Total GHG footprint. We are also members of the UN Global Compact.

HubStar are achieving a continuous reduction in GHG, without offsets, even though the company is growing at a substantial rate of over 100% annually over the last 3 years.



To help us get going on this journey, we've joined the UN's Climate Ambition Accelerator program, to learn more about setting science-based emissions reduction targets; and how to take ambitious corporate action to achieve net-zero by 2050. Our own Targets are to achieve Zero emissions by 2025.and we are on track to achieve this.

As a fully remote company that helps organizations right-size their real estate, improve utilization and implement hybrid working, it seems we can have a significant impact in terms of sustainability. Our Scope 2 GHG emissions are primarily generated in our hosting infrastructure with negligible Scope 1.




Carbon emissions (MTCO2e)
